You must complete this Claim Form to be eligible for compensation under the Settlement. Class Members who **submit a valid Claim Form by May 19, 2021** are entitled to compensation. Each timely, valid claimant will receive a payment based on the type and estimated amount of Class Products purchased during the Class Period. Submit only one (1) Claim Form per household.
